(v) Stated that yesterday 12/30/23 at approximately 1700 hours he went to the "Haburdasher" bar located at 43 W San Salvador St. (v) Stated that he parked his electric scooter on the sidewalk directly in front of the bar entrance. (v) Stated that he did not lock his scooter with a physical lock but did lock it with a "segway app" that does not allow the scooter to be turned on. (v) Stated that you would need the app and his cell phone password to be able to start the scooter and ride away with it. (r) Stated that he went into the bar and had a few "drinks" and at approximately 1800 hours came out and noticed his scooter missing. (v) Stated that he did not know who took his scooter, but the "bouncers" told him they saw a person riding off on his scooter. (v) Stated that he is not sure if the "bouncers" were telling the truth. (v) Stated that his scooter is a "Segway Ninebot" dark grey scooter with hints of yellow on the wheels. (v) Stated that the value of the scooter is \$800 dollars. (v) Stated that he did not call the police at the time of the incident but today came to the police station to file a police report. (v) Stated that he could positively identify his scooter and that he placed stickers on the handle/post with Joseph Carrillo and A-list celebrity in white lettering.
